Sandgate

Thank you for your letter of the 16th December which has just arrived. One disadvantage of putting a hotel on the Royal Kent site is that it is extremely doubtful whether anybody would build it. With capital, maintenance and running costs as high as they are, new hotels are almost impossible. Even when there is an 80% use I am told they are hard to make pay and from all the people I have talked to, I doubt whether you would get an 80% use at Sandgate taking the whole year into consideration. If, of course, the Sandgate Society can find anybody willing to run a hotel I am sure the Council would be only too pleased to permit one to be built.

The proposal is not merely to provide 15 additional shops in Sandgate but to replace 15 shops, which are likely to be needed for road widening, on the north side of the High Street by shops on the south side. This will have the advantage of concentrating shopping, provided there is some car parking in connection with it, and also enabling loading and unloading of to be done off the High Street.

Dear Mr. Tweddell,

Thank you for your reply to my letter of 7th December and quite understand the reasons for your inability to fix an alternative date for a meeting with some of our Committee.

We studied your Fourth Report regarding the Royal Kent/Caffyns site and have only two points to query -

1. There appears to be no provision for an hotel on this site which you had included in your earlier suggestions. What is the reason for abandoning the scheme for an hotel, especially in view of the non-existence in Sandgate of an hotel of worthwhile size?

In reply to the final paragraph of your letter, we think the scheme would fit in very well if the buildings to be erected were designed so as to be in harmony with Sandgate generally. Knowing your satiments regarding the re-development of Sandgate, we think this would be achieved if you were responsible for their construction and hope you will be called upon to act for the Council in this respect.

Finally, may I repeat our feeling that the erection of an hotel on this central site would be a worthwhile project and an amenity badly needed in Sandgate. I would add that the Royal Kent, in spite of its decaying condition, was well patronized right up to the last.

Report on meeting with the Developer's representitive, 22nd Nov., 1962., by Mr F. Norden, Deputy Chairman.

In company with Mr ^Anthony Swaine and Mrs Bennette (Ass't Sec'y) I met an appointment with Mr Lowther at the his offices in Brook Street, Mayfair during the afternoon of Nov. 22nd 1962.

We were most courteusly received and Mr Lowther invited remarks, when being assured that the purpose of our visit was not bound up with some plan for the retention of the Royal Kent Hotel as an intact building he expressed some relief and listened to the outline of our aims which were that, whilst acknowledging that re-development in certain parts of Sandgate High Street are both necessary and desirable we, as a Society were deeply concerned that no new building should be of such a kind that would spoil the character and layout of the village.

Mr Lowther was sympathetic of these ideals and some discussion ensued on what might go up and be mutually acceptable.

Mr Swaine postulated that the facade of the Royal Kent might be preserved and new structures adapted behind it to which Mr Lowther replied that his principals had not got an entirely free hand in the matter as they were restricted by The Folkestone Boro' Councils insistance that any new buildings should be so defigned and laid out to provide for gaps to admit views to the sea and daylight to the street (the local authorities have since changed their thinking about such provisions because such divisions between buildings would create wind tunnels and also possibly make way for the sea to enter the

street in certain tides)

It was acknowledged that the Developers would be concerned to ensure that any new dwellings and/or shops would have to be calculated in sufficient saleable numbers to enable them recover their outlays and to reserve a profit.

The conversation maintained a cordial level and terminated with Mr Lowter's promise that the Society should have access to any new plans which his principals might submit, bearing in mind that these first mx designed wre not acceptable to the Borough Council.

The New Inn

Of all Ford's scenes of village life, here is my favourite because it says so much. **SLIDE**

Here is the New Inn, built around 1775 and later known as the Royal Kent Hotel. In 1806 it was the principal coaching inn and was run by Richard Marsh. A lugger is beached alongside on what was William Hall's boatyard. Men at work busy caulking and a sailmakers loft on the far right. Its rather nice to see that sailboats still <u>SLIDE</u> beach here, this is the Saltwood Sailing Club which found itself becalmed.

And in the foreground, the recruting sergeant is getting the hapless yokels well ginned up, before pressing the King's shilling upon them More cannon fodder for the Peninsular Wars.

Those most ready to take the Sergeant's shilling were often 'the very worst characters, deserters from other corps, or on the run from the law. A third class -- perhaps more typical of Sandgate -- were composed of the sturdiest of our yeomen who, having increased the population of the parish without permission of the clergy, were glad to escape the consequences by sheltering themselves under the licence of the Camp.

'We worked hard' reports Rifleman Harris who served with a party recruting Militia volunteers ' I may say for three days and nights we kept up the dance and drunken riot. Every volunteer got ten guineas which, except for the two kept back for necessaries, they spent in every sort of excess till all was gone'.

SLIDE Many of us still remember the Royal Kent Hotel, a weatherboarded building with a pillared portico which lent enormous character to the High Street. It was quite typical of the old Folkestone Council and mafioso, to refuse to make a preservation order on this historic 18th century building, having already granted permission in May 1961 to the owners to demolish it. The Sandgate Society was quickly formed on the initiative of Mrs Greenwall in an attempt to bring pressure to save the building. But the developers as usual got their way. And what have we got in its place today. The John Moore block of flats which try to blend in, and Riviera Court designed in white and black and now painted goose-shit yellow. 

Preservation of old Sandgate, Kent.

We, the undersigned, having in mind the preservation of old Sandgate, the village in which we live, are most perturbed at the destruction of period houses and buildings which has taken place and is taking place here.

We are particularly worried over the future of "The Royal Kent Hotel"- an early coaching Hostelry which dominates the High Street. It is due for destruction next year, so we understand, and whilst we acknowledge the fact that the interior has been much neglected, we feel that the money which will be spent on pulling this old and lovely Inn down and replacing with hideous flats, could well be spent in preserving and renovating it. The lovely exterior is in good condition and its disappearance would ruin the whole character of Sandgate, which, although now part of Folkestone, still preserves its own individuality.

The other house which is of historical interest but which is allowed to fall into decay is the house in the High Street called "Corruna" which was occupied by Sir John Moore.

No plaque is on the house and no interest is taken in it by the Council. But the name of Sir John Moore is much honoured in Sandgate and Shorncliffe where he was C.in C., and where several roads and places are named after him, so it should be possible to preserve his home.

Re Sandgate Re-development.

As a resident for many years in the Folkestone/Hythe locality and as a Chartered Surveyor with 50 years experience of land development, I am astonished by and apprehenvive of the recommendations in Mr Tweddle's report. With respect to the author, it bears the stamp of hasty consideration followed apparantly by precipitate acceptance by the local Planning Authority.

The result of any attempt to enforce the terms of the report will be to stultify redevelopment of Sandgate which is urgently needed. May I suggest for consideration by the Minister the following points:-

1. I have never yet heard off the lips of any local resident of the " intimacy of Sandgate High Street so far as it derives from street plan. Even if it exists as a factor for consideration the widening of this important traffic artery which is urgently necessary will be to destroy it once and for all.

2. Apart from a few of thetblder houses on the South side which display the old Kentish tradition of weatherboard and sash windows, there is nothing worth retaining. Indeed the sooner most of the existing buildings are done away with the better.

3. The suggestion that heights of new buildings should be limited to three stories is quite incomprehensible. This would reduce the existing skyline by as much as twenty feet in places.

4. The area between the road and the sea wall is almost unique on the South East coast. It offers opportunities for redevelopment and improvement which can hardly be matched anywhere. to limit that redevelopment to so sparce a density as is suggested in the report will have one of two results:-

(a) It would be so uneconomic as to prohibit the removal of any existing properties or, alternitively,

(b) Should such redevelopment take place the demand for the resulting exiguous accommodation would limit the market to a comparatively few persons of exceptional means.

5. There is insufficient local trade to maintain the existing shopping facilities and in spite of the proposals in the report it is my view that no great or perhaps any increase in the number of residents would follow. This would, so far as trade is concerned, exacerbate an already difficult situation . On economic grounds it is my view that it is essential that redevelopment should provide for a more substantial increase in population than is envisaged in the report. 6. It is true that where the land between the road and sea front is already occupied by more than one plot depth redevelopment will present problems which may only be solved by a scheme sponsored by the Planning Authority, but this does not apply from No. 67 westwards. Here, private development is possible and should be **MNEXNIX** encouraged. The existing buildings are already such a height in places as to permit of more than four 8 ft. storeys without heightening the skyline and in my view at least two more storeys could be added without seriously overshadowing existing properties.

Moreover, density might reasonably be stepped up having regard to the illimitable open space of the sea itself. Further setting back from the existing road frontage to enable some measure of road widening on the south side would be possible if building line restrictions were not too drastically prescribed, for all the main rooms would face south and the close proximity of the road would not be a serious disadvantage to the new residents. The latter consideration can never apply to redevelopment of the North side.

I submit that in the hands of an imaginative architect the redevelopment of the westend of Sandgate would point the way to concerted action on the part of the present or future owners of the eastend and the present application appears to be founded on workable scheme with that end in prospect.

I greatly regret that owing to a previous engagement \ddagger cannot attend the hearing.

Herewith the papers about the launching of the new society at Ashford, which I hope will be of assistance to you. The amendments approved at the meeting on 5th inst. are not all shown.

I do not know whether the Royal Kent Hotel is a building listed under the Town and Country Planning Act, but I rather doubt it, in which case it will be difficult to save it, if it is in fact threatened by new development. I have written to the Folkestone Corporation to find out what plans exist in regard to its future. If it has already changed hands then we must watch what plans are presented for the re-development of the site by the purchasers. If it has not yet been sold, then your Society, about to be formed, or at any rate the residents of Sandgate, might try to find a purchaser who is desirous of retaining the building more or less with its present outward appearance. The question of a petition might also be considered, in addition to other forms of local representation.

I note in the minutes of our meeting held on 30th October 1961, must before I took over as Hon. Secretary, there is an item saying that there was a possibility of a local preservation society being formed at Sandgate, and I had been wondering what was the outcome.

You can rest assured that we are able, through our two parent bodies, to make powerful representations to appropriate authorities, and in this way back up local efforts, but we are not always successful.

DRAFT CONSTITUTION

1. NAME

The name of the Society shall be the ASHFORD & DISTRICT CIVIC SOCIETY.

2. OBJECTS

- 1. To encourage high standards of architecture and town and country planning in Ashford and district.
- 2. To stimulate public interest in and care for the beauty, history and character of the town and its surroundings.
- 3. To encourage the preservation, development and improvement of the features which contribute to pleasing and convenient conditions in which to live and work.
- 4. To pursue these ends by such means as meetings, exhibitions, lectures, publications, promotion of schemes and by co-operation with other local and national organisations and individuals concerned.

The Society shall have no political or religious activities and shall be non-profit making. h

3. MEMBERSHIP

Membership shall be open to all who are interested in the aims of the Society. Membership shall lapse if the subscription is unpaid 6 months after it is due.

4. SUBSCRIPTIONS

The subscriptions shall be determined at each Annual General Meeting.

5. MEETINGS

An annual General Meeting shall be held in or about June of each year to receive the Executive Committee's report and audited accounts and to elect Officers and Members of the Committee. The Committee shall decide when ordinary meetings of the Society shall be held and shall give at least ten days notice of such meetings to all members. Special General Meetings of the Society shall be held at the request of 20 or more members, of which ten days write Stall guen,

6. OFFICERS

Officers shall be nominated for election at or before the Annual General Meeting, and their election shall be completed prior to the election of further Committee members. The Officers of the Society shall consist of:-

> Chairman Vice-Chairman - to be elected by the committee Honorary Secretary Honorary Treasurer

all of whom shall relinquish their office every year and shall be eligible for re-election at the Annual General Meeting A President may also be elected at a General Meeting of the Society, for periods to be decided at such meeting.

Save the case of the Chairman, who shall not hold office In a consecutive term of more than three years.

7. COMMITTEE

The Executive Committee shall consist of the Officers and not more than ten further members. The Committee shall have power to co-opt further members (who shall attend in an advisory and non-voting capacity). The President may attend meetings of the Executive Committee but may not vote at such meetings.

Nominations for the Executive Committee shall be made at or before the Annual General Meeting. They must be in writing, supported by a seconder, and the consent of the proposed nominee must first have been obtained. If the nominations exceed the number of vacancies, a ballot shall take place.

The Executive Committee shall be responsible for running the affairs of the Society, and may take decisions and handle moneys on its behalf.

8. AMENDMENTS

The Constitution may be amended by a two-thirds majority of members present at an Annual or Special General Meeting, provided that ten days' notice of the proposed amendment has been sent to all members.

9. WINDING-UP

In the event of the winding-up of the Society the disposal of funds shall be decided by a majority vote at a General Meeting of the Society.

I enclose for your information a paper, which has been given wide circulation in the county and has been published in part in the press, on the aims and objects of this Joint Sub-Committee. We are anxious to offer our co-operation to all local societies whose aims may include the preservation of ancient or historic buildings.

A particularly troublesome problem at present is the re-development of old town and village centres, when proposals may be made for demolitions on a considerable scale. Our Sub-Committee feel that provided a purely negative attitude is not adopted and the undeniable claims of traffic and economics are borne in mind, it is often still possible to secure modification of schemes so as to ensure the preservation of worthy buildings.

Clearly the Sub-Committee cannot consider every such scheme in detail, nor would they presume to attempt duplication of efforts already being made locally by people with an intimate knowledge of the problems involved. But they are able, through the two parent bodies, to make powerful representations to the appropriate authorities, and in this way back up local efforts.

If your Society has a problem of this kind, and would let me have particulars of the proposals, which they are making to the authorities, the Sub-Committee would be very glad to consider them with a view to giving their support. It would be particularly helpful if plans and photographs (which will be returned if desired) could be included.

I am sure I do not need to emphasize the importance of getting information about development plans from the local authorities concerned at as early a stage as possible and asking for consultation.

PRESERVATION OF ANCIENT BUILDINGS IN KENT

The Council of the Kent Archaeological Society and the Committee for the Preservation of Rural Kent (a Committee of the Kent ^Council of Social Service) have set up a joint sub-committee to deal with the preservation of buildings of architectural and historic interest.

Old houses and cottages, follies, mills, oast-houses, barns, and other agricultural or industrial buildings may all, according to circumstances, merit consideration as being of historic or architectural interest. In addition, Kent has large numbers of buildings, both public and in private ownership, which may be as late as the early nineteenth century, but which are well worth preserving as examples of good architecture and because their removal, or replacement by unsuitable modern structures, would impoverish the urban or rural setting into which they naturally fit.

These buildings are often in danger from "development schemes," or may be neglected by their owners until the local authority steps in with a closing or demolition order. The terms of reference of the joint sub-committee are to consider all such cases which are brought to their notice and, if they think fit, to take action through the two parent bodies to save the threatened buildings and ensure their repair and proper maintenance.

In order to carry out their task effectively the joint sub-committee need the help of every member of the Kent Archaeological Society and every member of a Local History Group in the County. Official information will be received from time to time from the County Council, Society for the Protection of Ancient Buildings, Council for British Archaeology, and other bodies, but it is often the private citizen on the spot who first hears of a threatened demolition or knows of a neglected building, and who can, by reporting it promptly, enable action to be taken in time to be effective. Too often an interesting old house is destroyed or allowed to get into an advanced state of decay, without anyone knowing hout it outside the immediate neighbourhood.

Buildings of historic and architectural interest enjoy a certain amount of statutory protection, and the brief statement overleaf on the relevant legislation may be of assistance. Please make yourself familiar with the listed buildings in your area, and report any threat which comes to your notice. Photographs would be welcome, and suggestions for changing the grading if thought justified, particularly suggestions for upgrading.

Such records would, of course be specially valuable if a building could not be saved from demolition. Anyone who has such plans or photographs in his possession, or would be willing to undertake some original work of this kind in his own district, is earnestly requested to let the Hon. Secretary know. It will not be necessary to part with the documents unless the owner wishes, as arrangements have been made to have them photo-copied at a nominal charge. The copies will be deposited at the County Archives Office under the care of Dr. Felix Hull, the County Archivist, where anyone may consult them under the normal rules of the Office, copyright being retained by the owner.

Thenk you for your letter M/C/527/3 dated 8th January. I must apologise for the letter of 31st December 1962, which was despatched from this office in error.

We were interested to learn from the local Press, which was confirmed by your above-mentioned letter; that a Committee of Folkestone Borough Council have been considering the recommendation of Mr. Jellicoe that the Council should engage an architectural planning consultant for the borough, who would undertake the preparation of a redevelopment plan for Sandgate. We most strongly support this proposal.

We were, however, much distressed to read a recent report to the effect that when the matter was considered by the full Council the proposal was rejected. We cannot emphasize too strongly our view that full and careful consideration should be given to this question of redevelopment, which is such an important aspect of town life, and which can only be properly carried out by an expert in this field.

A Town Map for Sandgate would then enable all ratepayers, especially business concerns, to know precisely what and where future development is to take place, and in our view this feeling of stability arising therefrom far outweighs the expenditure of engaging a consultant.

We cannot help feeling that it would not be to the best advantage to expect any Surveyor's Department of any Local Authority, with its manifold day to day duties to perform, to undertake such a highly specialized task as this.

1. In agreeing to consult a specialist in Town and Country planning before passing any plans for rebuilding in Sandgate, the Folkestone Borough Council have shown themselves both far-seeing and wise. They have done what the Government is urging all local authorities to do.

2. Perhaps it is not fully realised that had the Council passed the original plans for luxury flats to be built on the site of the Royal Kent Hotel and Caffyns, the building would have taken enything from five to eight years to complete, because of the grandices scheme for three huge blocks of 9 storey flats covering the whole of the area from Dranville Road West to Devonshire Terrace. At least three of the properties now standing on that site have still three years lease to run, whilst other property owners are not willing to sell out and would have gone to arbitration had their properties been requisitioned in order to carry out a scheme by speculative builders.

The Preservation of Sandgate.

Thank you for the newspaper cutting about the Folkestone Town Centre Plan.

I have not addressed you yet as the Secretary of the Sandgate Preservation Society, because I thought perhaps you would not wish this to be known just yet, but I should imagine that now you are formed the sooner you made yourselves known the better.

Do not be alarmed by what has been discussed at Folkestone. I am sure your next step is for one or two of you to make an appointment with the County Planning Officer at Maidstone, if he will see you, and ask to see the County Development Plan, in relation to Sandgate High Street. I think you will find there is nothing concrete about the trunk road, and in any case you may find it is a trunk road only from Folkestone to Hastings, and, therefore, of minor consideration.

Reading through the newspaper report I see that reference is made to the Town and Country Planning Act, and the re-development of obsolete development is only a matter of opinion as to whether it is obsolete or not.

I have passed on to Mr. Chettoe the good news that you have started off, and it is intended to bring up the matter of Sandgate at one of our County Meetings as soon as possible. The fact that the people in the Town Hall at Folkestone may wish to amuse themselves plotting and planning what they think is good planning is rather beside the point. Before any area can be developed on such a scale it must become part of the comprehensive development plan, and,I think is not valid until it has received the consent of the Minister. All this takes a long time, and you have a right to put in a plan yourselves if you so wish, and this has been done in other places. In any case I think the County Planning Officer would be quite prepared to consider any proposals you put forward, and you might well find that many of your views could be incorporated into any plan that might become part of the Development Plan, in the same way as many of our ideas have been adopted here in Canterbury.

There are two grave dangers to any town like yours, one is piecemeal development by private people who are only concerned with making money, the other is the rather inhuman machinery of local or central government schemes.

I am sure your wise course is to go direct to Maidstone, and in this you might find Mr. Walton, the Deputy County Planning Officer prepared to meet you.

Do let me know if there is anything you think I could do.

1. I am directed by the Minister of Housing and Local Government to say that he has considered the report of the Inspector, Mr. C. Hilton, B.A., A.R.I.B.A., M.T.P.I., on the local inquiry into the following appeals by your client, Mr. C. C. Fyson:-

- (a) under section 16 of the Town and Country Planning Act 1947 (now section 23 of the Town and Country Planning Act 1962) on to an application for planning permission for the erection of a public house, restaurant, shops and flats with car parking facilities on land described in the heading to this letter in respect of which a decision was not issued by the Folkestone Borough Council, acting on behalf of the Kent County Council within the prescribed statutory period, hereinafter referred to as <u>Appeal 'A'</u>; and
- (b) under section 23 of the Town and Country Planning Act 1962, on an application for planning permission for the erection of 5 lock-up shops and 36 selfcontained flats, with covered car parking and rear access and loading facilities, on the said land, in respect of which a decision was not issued by the Folkestone Borough Council, acting on behalf of the Kent County Council, within the prescribed statutory period, hereinafter referred to as Appeal 'B'.

2. The Minister notes that at the inquiry it was stated on behalf of your client that he no longer wishes to proceed with <u>Appeal 'A'</u> and the Minister has therefore decided to take no further action in respect of that appeal.

7. The Inspector in his report, a copy of which is enclosed, concluded with regard to <u>Appeal 'B'</u> that viewed solely in the light of existing conditions the proposal must be regarded as inappropriate and unacceptable. Not only was the density of the development proposed exceptionally and unjustifiably high but a building of seven storeys would be quite out of place in Sandgate High Street and would destroy whatever charm and character this small seaside resort might possess. Little is known of its early history except that it was used as a centre for Cockfighting and much frequented for this purpose by young men in the surrounding villages.

It was also, reputedly, a smuggler's haunt, and used extensively by persons travelling between Portsmouth, Brighton and Dover.

The name was changed to The Royal Kent Hotel in 1855.

The building now used as an annexe to the Hotel was built for Sarah Siddons who was a constant visitor to Sandgate. The appropriate photograph is marked on the back.

The Royal Kent Hotel can truthfully be said to dominate the centre of Sandgate giving it much of its old world charm and its removal would be like tearing the heart out of the little village.

With further reference to your letter of 13th September, which was read to the members of the Housing and Town Planning Committee at their last meeting, the Royal Kent Hotel was not included in the list prepared in 1949 by the Ministry of Town and Country Planning (now Housing and Local Government) of buildings of special architectural or historic interest in accordance with section 30 of the Town and Country Planning Act, 1947. The Committee have noted that the Ministry now regard this as a border line case, but, in the view of the members, this is not a building which should be the subject of a preservation order and they have confirmed their previous decision which granted outline permission for the redevelopment of the site.

The reason for the Committee's recommendation to the Council was that the character and condition of the building did not justify the making of a building preservation order, with the consequent heavy expenditure and furthermore a proposal to make an order would inevitably delay redevelopment of the area, which in the Council's view, is a matter of considerable importance to Sandgate. I have mentioned heavy expenditure and your members will appreciate that, in addition to the cost of acquisition, (and this would include the benefit of the planning permission) there would be the cost of restoration and subsequent maintenance to be borne by the ratepayers.

Your members will undoubtedly be aware that a short time ago, the Council decided that consultants should be engaged to report upon the possible redevelopment of part of Sandgate, which includes the site of the Royal Kent Hotel, as it is the Council's desire that any scheme which ultimately is approved will have the most careful consideration throughout the various stages. A suggestion was made at the Council meeting last evening that the proposed developers be requested to contact you and the Joint Sub-Committee for the Preservation of Ancient Buildings in response to your request that demolition might be deferred until the two bodies have had an opportunity of putting forward their suggestions for the preservation of the building and I have written to the developers' Surveyors requesting them to contact you in this connection.

No doubt your members will also be interested to know that a sketch plan and drawing for the redevelopment of the site of the Royal Kent Hotel for the erection of shops, licensed premises. restaurant and flats, which illustrated the manner in which similar development could be undertaken on adjoining sites, was submitted to the Housing and Town Planning Committee. This was an informal submission for the views of the Corporation at this stage. The Committee decided they would require further information upon the effect of the proposed buildings upon the daylight to premises opposite the site. but. in view of their opinion that this is a matter of considerable importance, they have engaged a consultant architect, whose name was forwarded by the Royal Institute of British Architects, to advise them upon this proposed development and its probable effect in relation to redevelopment of adjoining areas in Sandgate. I trust from this that your members will appreciate the great importance which the Council attach to this matter and to the care which is being exercised in ensuring good redevelopment for the area.

As one of those to whom you refer at the beginning who criticised the Council at the recent meeting of the Sandgete Preservation Society, may I put forward again the essence of that criticism, which I might add has also been presented so ably in the letter of Sir Thomas Rapp of the same date?

The essence of my criticism was, and still is, (and a study of your leading article bears me out) that at no time did the Council seek public support for a major re-development scheme in the heart of Sandgate to which it gave outline planning approval, which involved, inter alia, the demolition of the Royal Kent Hotel, as long ago as 9th May, 1961. The fact that this approval had been given only came to light in correspondence with the Council as a result of the article that appeared in your edition of 1st September, some 16 months later. In this article the public of Sandgate learnt for the first time that the hotel was closing down in a fortnight's time, and demolition was due to commence on 1st November.

Earlier this year the Ministry of Housing and Local Government and the Ministry of Transport jointly published a most interesting and instructive brochure entitled "Planning Bulletin 1. Town Centres - Approach to Renewal" of which I hope the Council, and anyone interested in town re-development, have a copy. The three most important points, in my view, raised in this bulletin can be summarised as follows:-

(a) Every town has a character of its own, and underlying all other objectives will be the wish to retain and enhance its individuality. It should not be lost in the process of renewal.

- (b) In all forms of urban renewal, from "fix up and paint up" to large-scale re-development, the authority must carry local public opinion with them if their policy for renewal is to succeed, and from the start they should seek the greatest possible measure of public interest and involvement in the plan.
- (c) From the outset the local authority should treat publicity as one of the crucial factors in planning for renewal. Provided the status of the preliminary plans and the tentative nature of the first proposals are made clear, there is everything to be gained by putting them before the public.

While the people of Sandgate, and others interested in preserving ancient buildings which they consider worth preserving, may not have succeeded in saving the Royal Kent Hotel, let us hope that the Council will in future take the public into their confidence, and will not again confront them, when they open their local paper, with a fait accompli in a matter of general interest affecting their lives.

A suggestion was made at the Council meeting last evening that the proposed developers be requested to contact you and the Sandgate Preservation Society in response to your request that demolition might be deferred until the two bodies have had an opportunity of putting forward their suggestions for the preservation of the building and I have written to the developers' Surveyors requesting them to contact you in this connection.

No doubt your members will also be interested to know that a sketch plan and drawing for the redevelopment of the site of the Royal Kent Hotel for the erection of shops, licensed premises, restaurant and flats, which illustrated the manner in which similar development could be undertaken on adjoining sites, was submitted to the Housing and Town Planning Committee. This was an informal submission for the views of the Corporation at this stage. The Committee decided they would require further information upon the effect of the proposed buildings upon the daylight to premises opposite the site, but, in view of their opinion that this is a matter of considerable importance, they have engaged a consultant architect, whose name was forwarded by the Royal Institute of British Architects, to advise them upon this proposed development and its probable effect in relation to redevelopment of adjoining areas in Sandgate. I trust from this that your members will appreciate the great importance which the Council attach to this matter and to the care which is being exercised in ensuring good redevelopment for the area.

I understand the Sandgate Preservation Society has already written to you on 27th August and 2nd September in connection with the threatened demolition of the above hotel. This Committee is most concerned over the matter, and I am writing to inform you of the present position and to ask if there is anything you can possibly do to make demolition the subject of approval so that the matter can be threached out before we are faced with a "fait accompli".

We were informed in July by the Folkestone Council that plans for re-development had not been approved pending consideration of a comprehensive development plan for the whole area and it is only yesterday that I was informed, as a result of a personal interview with the Borough Surveyor, that it is the detailed plans which are being considered. Demolition itself is a foregone conclusion and not in fact an issue under consideration by the Council at all. Outline permission to redevelop this site was given 2 or 3 years ago and agreement to the demolition was implied in this. No permission is required to demolish as this building is only on the Supplementary List, and the Surveyor understands that the developer is likely to start demolishing as soon as he gains possession in October whether his detailed plans for redevelopment have been approved or not.

We are taking steps to obtain a detailed report on this building on which we hope to base positive suggestions for its preservation, but obviously we shall be too late unless a check can be put on out of hand demolition in the next fewweeks.

We shall be very grateful indeed if you can help in this matter.
