

#### THE CHICHESTER MEMORIAL.



The building which is to constitute a memorial to the late Lilla Countess of Chichester is now being erected in the High Street, Sandgate. It will be a fine structure, containing a large hall capable of seating 300 people, a workmen's club, with a billiard room (two tables), card room, usual offices, and caretaker's quarters. Mr. Master has kindly provided a screen for the large Hall, so that for Parochial uses, Women's Meetings, Red Cross Society Meetings, &c., extra accommodation will be provided. The contract price for the whole building is £1,241. The total amount already subscribed and collected is £719. There thus remains the sum of about £600 (including cost of furniture, etc.) to be raised. As it is the hope of the Committee that the premises when opened shall be free from debt, they earnestly plead for further subscriptions, which will be thankfully received and acknowledged by the Hon. Secretary, Mr. A. H. Ullyett, Head Master's Residence, Sandgate.

On Monday afternoon, in the presence of a large and interested assembly, Sir Squire Bancroft laid the foundation stone of the building which is being erected in the High-street as a memorial to the late Lilla Countess of Chichester, and which will be used as a workmen's club and as a meeting place of various useful organisations. Besides Sir Squire Bancroft there were also present on the platform: Councillors J. H. Maltby (Chairman of the Sandgate Council), Dr. J. C. O. Bradbury, J. H. W. Huntley, and H. T. Longly, the Mayor of Folkestone (Alderman S. Penfold, J.P.), Councillor E. J. Bishop (Folkestone), the Revs. A. Trevellick Cape (Pastor of Sandgate Weslevan Church) and Alexander Wilson (Pastor of Congregational Church), Messrs. C. H. Master, J.P., D.L. (Chairman of the Chichester Memorial Committee), F. E. Burke, J.P., A. H., 'Ullyett (Hon. Secretary and Treasurer), J. Shera Atkinson (Clerk to the Sandgate Council), and Architect of the building). Seated in a motor car drawn up close to the building were Lady Bancroft. Mrs. Master, and Mrs. Burke.

Mr. MASTER apologised for the absence of the Rev. Tufnell Barrett, who was unable to be present on account of his wife's illness. In all life, he contended, the chief thing to do was to make sure to give to the right man the tribute which belonged to him. On November 9th last the contract for building the Chichester Memorial Hall and Working Men's Club was accepted for the sum of £1241.

On December 15th the Memorial Stone was laid by Sir Squire Bancroft and the event was fully reported in the "Folkestone Herald," a cutting from which is enclosed.

On December 22nd the first certificate for £400 was paid to the builder, leaving an approximate credit balance of £400.

A further sum of £600 is required to completely finish the building, provide lighting and heating apparatus, and certain necessary articles of furniture.

The Committee have received a very generous offer from Mr. Master and Mr. Burke, who have promised to give jointly a cheque for £250, provided a similar sum of £250 is subscribed within six months from February 1st, next.

The Committee most earnestly appeal to you on behalf of this outstanding balance of £250. Any contribution however small will help towards its liquidation, and enable the Committee to accept a cheque only waiting to be drawn.

Any sum sent to me will be gratefully acknowledged, or cheques may be paid in to Lloyd's Bank, Sandgate, to the credit of the above fund.

As we all know, the present Chichester Memorial Trust was set up/in 1990 the community hall built by public subscription, when destined to be closed down and sold off by a Conservative dominated District Council, which incorporated the former Folkestone Borough Council.

After many years of non-replacement of Trustees and 'limbo', the above Notice is most encouraging in that procedures are afoot to ensure the maintenance, running and use of the local community hall, initially through the appointment (as proposed) of five named Trustees. They all form part of the eleven member Parish Council and all, except one, voted in on a party political ticket including the Chairman.

The proposed Trustees are all capable, well-respected residents in the new-born Parish (est. 2004) but have been suggested to the exclusion of other experienced and highly regarded residents within the borders of the former Sandgate Urban District Council (merged with Folkestone BC in 1934).

Though I have not seen the Trust deed, it has always been my understanding that the Trustees should be drawn from within the boundaries of as above. In fact, as a local historian, my help was sought in defining these boundaries.

Negotiations have been carried on in strict secrecy by past and present Sandgate Parish Councils, notably since May 2007 by Chairman Geoffrey Boot personally. Under Local Govt Act 1972, s.133 the Council does have power to provide buildings inter alia for public meetings and assemblies and, in this case we would hope, additional funding.

My first question is how long are the nominated trustees expected to serve?

Secondly why should not trusted and well-known residents of the wider community be invited to serve. Obviously all trustees would report back to the Parish Council as presently designated by a recent Referendum? As yet, there has been no open consultation.

Without prejudice, I would add that one of the proposed Trustees is also a District Councillor and in view of her heavy committments, is, perforce, giving up her valued leadership and in put in the VDI -- Village Design Initiative.

The sooner we can look forward to the satisfactory running of the Chichester Meorial Hall, the better. Meanwhile, I would apprecitate a full answer to my concerns. A copy of this letter is being sent to the Sandgate Society (Reg. Ch. 287281) of which I am a founding member 1962. Current membership around 470.

The proposed alterations to the Chichester Hall were discussed at a recent committee meeting of the Sandgate Society. Concerns were expressed about the effect on the external appearance of the building of the proposals, particularly the installation of a ramp on the south elevation and the insertion of a lift into the south-east comer of the building.

It was said that this ramp and lift were required to satisfy the need for disabled people to access the first floor hall. The proposals also include a ramped rear access, which the committee felt would achieve these needs.

It is said that an alternative means of escape is required in the event of the failure of the lift, and that is the justification of the rear access. However, it is our belief that means of access for wheel chair users be achieved by the single rear access alone thus obviating the need for substantial alterations to the front elevation including the 'blinding' of the windows on the southeast elevation which is likely to be an inevitable consequence of the installation of the lift.

We consider that the applicants should be asked to reconsider these proposals in the interests of the original appearance of this important civic building in the streetscape.

PLANNING APPLICATION, SH/75/1222 - CHICHESTER HALL, SANDGATE.

I write to you on behalf of the Sandgate Society to say that they strongly disagree with the above planning application, to render the exterior walls of the Hall, particularly those which have not been thus treated hitherto. They urge that the brickwork and stonework be repaired; there are many interesting details in this brickwork which would be impossible to retain if the building were rendered, and it would seem in direct contradiction to the policy and plan so recently put forward by Shepway in its Study of Sandgate - an Informal District Plan, in which local owners are encouraged to restore their houses to their original condition, and if this proposed change were made it would set a poor example to the rest of the District. The Chichester Hall, being one of the first buildings to be repaired and restored by the Council, will be keenly observed, and it is asked that due respect should be paid to the recommendations made in the Appendices Volume (page 17).

The Society feel certain that this letter will have the approval of the Planning Committee in view of the assurances made by the Chairman of the Development Committee at the recent meeting. Whilst appreciating that to repair the brickwork etc. would possibly be more costly, it is felt locally that very little had been spent in the past (by the former borough council) in maintaining this handsome building in the very centre of Sandgate, and that proper restoration would be an investment, both aesthetically and in practical terms.

Further to our recent conversation and your letter dated 13 April 1983, I wish to acquaint you with the following information regarding the Chichester Hall:-

- (a) The existing wooden seat outside the building will be refurbished and negotiations are taking place with the Sandgate Society for a similar seat to be provided in place of the telephone kiosk.
- (b) The existing wire netting will be replaced with a smaller mesh netting in an attempt to stop birds nesting above these seats.
- (c) The bare woodwork on the front door has now been painted.
- (d) The existing toilets and seats adjacent to the entrance door will soon be replaced.
- (e) A twin 13 amp power point is to be installed in the kitchen, together with an electric kettle and, possibly, a number of cups and saucers, etc.
- (f) The bare patches of wall surrounding the new gas heaters have been painted.
- (g) New window catches have been fitted to all sash windows that open.
- (h) The stage curtains are at this moment of time in my office waiting to go to the laundry prior to being rehung.

With regard to the cleaning of the floor, the contractor and the Council's Building Surveyor recommend that it is lightly washed with a mop and then coated with "Bournseal" once, or possible twice, a year dependent upon use.

I have been in touch with Mrs. Lachlan of the Sandgate Society regarding the Caretaker leaving our service and am hopeful that she will be able to recommend somebody local as a suitable replacement.

#### Chichester Memorial Hall, Sandgate, Kent

Thank you for your letter dated 23 June explaining the history of the Hall which makes interesting reading.

Our records show that the current governing document for this Hall is a Scheme made by the Charity Commission dated 19 June 1990 which replaced the original trusts set out in a conveyance dated 1 February 1918. This Scheme provides for the Hall to be used as a village hall for the residents of the former Urban District of Sandgate (to which we added the ecclesiastical parish of Sandgate as constituted in 1918 by further short Scheme we made on the 4 March 1991). The Scheme states that the Hall should be managed by a committee of 7 members elected at an annual general meeting and representatives members appointed by the groups which use the Hall. The annual general meeting has to be held in May or "as soon as practicable thereafter". The Committee may also co opt two members. The Hall buildings are vested in the Official Custodian for Charities who acts as a holding trustee for charities to hold title to land. I am enclosing some information about the Official Custodian's land holding service to explain his role.

If you would like a copy of the 1990 and 1991 Schemes you can obtain them by contacting Charity Commission Direct, PO Box 1227, Liverpool, L69 3UG (telephone 0845 3000 218). There will be a copying charge.

We have been told that at the moment there is no proper Committee running this Hall and the purpose of the current Order is the legal way in which the Commission can appoint individuals who can sort out the administration of the Hall and then hold the Annual General Meeting, to put the administration back on a proper footing in accordance with the 1991 scheme. However, if once appointed the new trustees find that the 1990 scheme is no longer practicable they may consider altering it, possibly with our assistance before calling an AGM.

To answer your three numbered points.

- 1. I would expect the trustees to serve until they can call an Annual General Meeting to arrange for a new committee in accordance with the 1991 Scheme. I do not know exactly how long this might take but I anticipate it may take some months. As I mentioned above, it may be that once in place the trustees decide they need to make some changes to the Scheme and affect how the charity operate and trustees are appointed.
- 2. It is difficult to answer your question because I do not know exactly what you mean by local well known residents. I can only say that a committee established in accordance with the terms of the present scheme allows for local residents to elect 7 members and for organisations that use the Hall to appoint representative members (which include in the original list of users in the Scheme, the Sandgate Society). Plus if the Committee wishes it may co opt one or two additional members.
- 3. The Hall is already vested in the Official Custodian for Charities and at the moment I have not been asked to alter this vesting to the Parish Council.

I hope this answers all your queries. If you want to know anything further about the trustees' plans for the future I suggest you contact them direct.

As we all know, the present Chichester Hall Memorial Trust was set up in 1990 to save our community hall (erected by public subscription) at a time when the Conservative dominated Shepway District Council (which incorporated the former Folkestone Borough Council) decided to close it down and sell it off

Though I have not seen the Trust Deed, it has always been my understanding that the Trustees should be drawn from within the boundaries of the former Sandgate Urban District Council, later merged with Folkestone Borough Council 1934) In fact, as a local historian, my help was sought in ascertaining the old UDC boundaries.

After many years of non-replacement of Trustees and 'limbo' the above Notice is most encouraging in that procedures are afoot to ensure maintenance, good running, accountability and use of our valued community hall, originally built by public subscription and opened in 1914. By indenture 1 February 1918 the land and property was vested in the Sandgate Urban District Council and successors who, with a committee of five members were to maintain the Hall etc. etc.

Today, the five proposed members or Trustees are all capable people known to me personally. Though they are all parish councillors among ten Conservatives elected to an ll-member council, I gather that they have consented to serve in a private capacity as members of the Sandgate community, and undertaking the responsibilities and liabilities accordingly.

Negotiations have been carried out, necessarily in strict confidence, by past and present Sandgate Parish Gou ncils, notably by Chairman Boot personally since May 2007. Under Local Govt Act 1972 s. 133 the Council does have power to provide buildings, inter alia for public meetings and assemblies and, in the present case we would hope, additional funding.

As yet, there has been no opportunity for public consultation or by important bodies in the area. My question are:

- 1. How long are the mamina proposed Trustees expected to serve in the first instance
- 2. Can you say whether, in due course, well-known residents in the wider community will be invited to serve
- 3. Will the Hall be nominally vested, by instrument, in the Parish Council and will it be run by a management committee

The sooner we can look forward to the satisfactory running of the Chichester Memorial Hall, the better. Meanwhile I would appreciate a full answer to my concerns A copy of this letter is being sent to the Sandgate Society (Reg.Ch. 287281) of which I am a founding member since 1962. Current Membership around 470.





Local antique dealer Mr Frank Freeman said the clock was full with 100 years of filfth and dirt plus birds' droppings and nests.


Two years ago a decision was made by members of Shepway District Council's Amenities Committee not to repair the clock because of a lack of money.

#### CONDITIONS OF CONTRACT

- 1. This quotation is open for acceptance within three months from the date thereof, and is subject to Reliant Scaffolding having labour and materials available, and receiving reasonable notice to commence work within six months after receipt of the Hirer's order.
- 2. Reliant Scaffolding will exercise all reasonable care to ensure that the structure is soundly and adequately constructed for the purpose requested by the Hirers and that when constructed it will comply with all current statutory regulations applicable. Reliant Scaffolding undertake to remedy at their own expense any defects drawn to their attention in writing which have arisen from faulty erection by Reliant Scaffolding or the use of defective equipment by Reliant Scaffolding. Any other defects drawn to the attention of Reliant Scaffolding in writing will be remedied by Reliant Scaffolding at the Hirer's expense.

The Hirers shall comply with and use their best endeavours to cause their employees and other sub-contractors and their employees to comply with the safety clauses set out overleaf and all other provisions which are to be observed by the Hirers or other sub-contractors in any statutory safety regulations. - 4. Only minor alterations to existing structures required by the Hirers will be carried out at Daywork rates, plus expenses agreed and authorised. Where any work is carried out at Daywork rates, the total number of hours booked, as shown on Reliant Scaffolding's daily time cards or time sheets, will be chargeable at the rates shown in this quotation.
- 5. Unless otherwise provided in these conditions, Reliant Scaffolding will indemnify the Hirers against all sums for which the Hirers shall become liable as and for compensation for bodily injury or death of any person or damage to any property caused by the negligence of Reliant Scaffolding in erecting or dismantling the equipment or by the use of defective equipment by Reliant Scaffolding. Further to your letter of 29 October I have been in touch with Mr. Freeman, and I understand Mr. Dennis(whose estimate for repair and refurbishing was £800) thinks he might be able to manage with a 'hoist', and I have been in touch with Mr. Wilson of Shepway Council to try and find out how much this would cost. I still don't know this, but it is possible that he has been in touch with you and Mr. Dennis direct — indeed I hope so as it is very difficult being middleman as it were, on a subject I have no knowledge of.

I am told it would be at least three weeks between taking down the clock, and repairing and checking its movement, before it could be replaced a so it might be that a moveable means of erection would be more economical than one which has to stay in situ until the work is finished.

I have spoken to a scaffolding firm and enclose a copy of their estimate.

The fund stands now at £716. Apart from the generous contribution of the Charter Trust the amount is made up of small subscriptions for the most part, and very much reflects the wish of the residents to have the Clock going. We should be very grateful to be considered for a grant for this purpose.
