INTRODUCTION.

To render the account of the Marriage rejoicings here of value as a record of this important national event, and to serve as a book of reference on a future occasion, however remote, it is interesting to narrate that the Princess, accompanied by her Royal Parents, Brothers and Sisters, arrived in Margate Roads, in Her Majesty's Royal Yacht "Victoria and Albert," on the 6th March, 1863, convoyed by several of H.M. ships, under Admiral Smart, of the Channel fleet, and on the following day landed at Gravesend Pier with great pomp, the Volunteers of Kent, under Viscount Sydney, Lord Lieutenant of the County, forming a guard of honour; from thence by the North Kent Railway to the Bricklayer's Arms station, making her triumphal entry through London, and by the Great Western Railway to Windsor Castle, on Saturday the 7th March; and on Tuesday, the 10th March, the Marriage was solemnised at the Chapel Royal, Windsor, with the accustomed state ceremonial of such occasions, the ceremony being performed by the Archbishop of Canterbury, after which the Royal Pair proceeded to Osborne, Isle of Wight.

At the re-assembling of Parliament, on the 5th day of February, 1863, under the premiership of Viscount Palmerston, K.C.B., Lord Warden of the Cinque Ports, &c., &c., &c., it was announced in the Royal Speech (which was delivered by commission) that Her Majesty had given her consent to this Marriage, and asked her faithful Commons to grant to their Royal Highnesses a suitable provision. Accordingly, on the 5th day of March, 1863, the following act was passed:—

CAP. I.

An Act to enable Her Majesty to provide for the Establishment of His Royal Highness the Prince of Wales and Her Royal Highness the Princess Alexandra of Denmark, and to settle certain Annuities on Her Royal Highness.

5th March, 1863.

Most Gracious Sovereign,

WHE Your Majesty's most dutiful and loyal Subjects, the Commons of the United Kingdom of Great Britain and Ireland in Parliament assembled, having taken into consideration Your Majesty's most Gracious Message that Your Majesty has agreed to a Marriage proposed between His Royal Highness Albert Edward Prince of Wales and Her Royal Highness the Princess Alexandra Caroline Maria Charlotte Louisa Julia of Denmark, do most humbly beseech Your Majesty that it may be enacted; and be it enacted by the Queen's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, as follows:—

1. It shall be lawful for Her Majesty, in order to provide for the Establishment of His Royal Highness the Prince of Wales and Her said Royal Highness the Princess Alexandra, by Letters Patent under the Great Seal of the United Kingdom of Great Britain and Ireland, to grant to His said Royal Highness or to such Persons as Her Majesty may think fit to name in the said Letters Patent, in trust for His said Royal Highness, an Annuity of Forty thousand Pounds, to commence from the Day of the Marriage of His said Royal Highness with Her said Royal Highness, and to continue during the joint Lives of Her Majesty and His said Royal Highness, to be paid quarterly on the Fifth Day of January, the Fifth day of April, the Fifth Day of July, and the Tenth Day of October in every Year, the first payment to be made on such of the said quarterly days as next happens after the said Marriage, of such Portion of the said Annuity as may have accrued between the Date of the said Marriage and the said quarterly Day, and a proportionate Part to be payable for the Period from the last quarterly Day of Payment to the Day of the Determination of the Annuity.

2. It shall be lawful for Her Majesty, by Letters Patent under the Great Seal of the United Kingdom of Great Britain and Ireland, to grant unto Her Royal Highness the said Princess Alexandra, or to such Persons as Her Majesty may think fit to name in such Letters Patent, in trust for Her Royal Highness, for Her sole and separate Use, but without any Power of Anticipation, an Annuity of Ten thousand Pounds, to commence from the Date of the Marriage of Her said Royal Highness with His Royal Highness, and to be payable during the Continuance of that Marriage, on the quarterly Days aforesaid, the first Payment to be made on such of the said quarterly Days as happens next after the said Marriage, of such Portion of the said Annuity as may have accrued between the Date of such Marriage and such quarterly Day, and a proportionate Part to be payable for the Period from the last quarterly Day of Payment to the Day of the Determination thereof.

3. It shall be lawful for Her Majesty, by Letters Patent under the Great Seal of the United Kingdom of Great Britain and Ireland, to grant unto Her said Royal Highness, in case of Her surviving His said Royal Highness, or to such Persons as Her Majesty may think fit to name in the said Letters Patent, in trust for Her said Royal Highness, in the event of Her so surviving an Annuity of Thirty thousand Pounds, to commence from the Day of the Death of His said Royal Highness, and to continue from thenceforth during the Life of Her said Royal Highness, and to be payable on the quarterly Days aforesaid, the first Payment to be made on such of the said quarterly Days as happens next after the Death of His said Royal Highness, of such Portion of the said Annuity as may have accrued between the Date of the said Death and the said quarterly Day, and a proportionate Part thereof to be payable for the Period from the last quarterly Day of Payment to the Day of the Determination thereof.

4. The Annuities granted by this Act shall be charged on and payable out of the Consolidated Fund of the United Kingdom of Great Britain and Ireland, after paying or reserving sufficient to pay such Sums as may have been directed to be paid out of the said Fund by former Acts of Parliament, but with Preference to all other Payments which may hereafter be charged on the said Fund.

The grants to their Royal Highnesses were considered moderate, and the Act passed both Houses of Parliament without opposition.

The demonstrations of loyalty were under the management of a Committee, at the "Royal Kent Hotel," who delegated power to a Committee of Ladies for the Children's Tea. It is a pleasing duty to bear testimony to their zeal and untiring energy, especially of an amiable and benevolent lady, who has been conspicuous for years in promoting the growth of moral and religious instruction among the children and youth of this place.

Material aid and assistance was likewise given by the Incumbent, and the Rector of Cheriton and Newington, and their families, in officiating and superintending the feasting of the children at the National Schools.

The children at the close of the afternoon procession adjourned for a time to the beautiful grounds of The Hon. Sir John Duncan Bligh, K.C.B., and on the terrace fronting the Mansion, sang the National Anthems of England and Wales. The weather during the procession was unsettled, wind south, with a little rain and sleet.

Illuminations were general through the place, comprising gas devices, variegated oil lamp devices, and Chinese lanterns, and the day was observed as a general holiday. The Coast Guards numbered 16 men, under Commander Wrake, R.N. The 11th Kent Artillery Volunteers numbered 32 men, under the command of Lieut. Goodban. The Kent County Constabulary Force numbered 11 men, under the command of Superintendent English. The rejoicings were witnessed by a large body of troops encamped at Shorncliffe, some of whom joined the evening procession, consisting of the 78th Highlanders (Col. John Ewart, C.B.), 84th York and Lancaster (Col. Thos. Lightfoot, C.B.), a squadron of 9th Lancers (Captain Henry Marshall), five Batteries 9th Brigade Royal Artillery (Col. John W. Ormsby), Company Royal Engineers (Capt. Lempriere).

The returns for the Public Dispensary on the day of the Royal Marriage was—9 Patients; this taken in connection with the census returns is only '005 $\frac{1}{2}$ cent. of sickness to the population of Sandgate (or one person sick in every two hundred).

At the Children's Tea were consumed 255 lbs. Plum Cake, 800 Buns, 7 gallons Bread, Tea, Milk and Water, 400 Oranges, Wine and Water. The Committee distributed by tickets to the Poor 261 $\frac{1}{2}$ lbs boneless Beef, 107 gallons Bread, and 102 cwt. Coals.

Cost of Provisions: Plum Cake, 7d. per lb.; Bread, 12d. per gal.; Beef, 7d. per lb.; Coals, 14d. per cwt.



Was echoed on this Kentish shore.



1988 marks the 125th anniversary of the marriage of H.R.H. The Prince of Wales to H.R.H. The Princess Alexandra of Denmark. By way of celebration the residents of Sandgate, held on Tuesday March 10th 1863 a Loyal Demonstration. Two processions were held one at 2.00 in the afternoon, and another later in the evening by torchlight, when coloured fires and Signal Rockets were fired. Four hundred children were provided with tea, cake oranges and wine, whilst the volunteers, Coast Guards and Police attended a Public Dinner.
